ACKNOWLEDGMENT AND AGREEMENT

Notes:

- 1. No Club/ Participant may participate in a SGHA event/ tournament/ league until he/she has signed this acknowledgment and agreement.
- 2. This acknowledgment and agreement must be received by the SGHA Office at **least 1 MONTH** before the start of an Event/ Tournament/ League.

SGHA CODE OF CONDUCT

- 1. I have received and had an opportunity to review the SGHA Code of Conduct.
- 2. I consent and agree to comply with and be bound by all of the provisions of the SGHA Code of Conduct.

FIH ANTI DOPING REGULATIONS

- 1. I have received and had an opportunity to review the FIH Anti-Doping Regulations.
- 2. I consent and agree to comply with and be bound by all of the provisions of the FIH Anti-Doping Regulations, including but not limited to, all amendments to the FIH Anti-Doping Regulations and all International Standards incorporated in the FIH Anti-Doping Regulations.
- 3. I acknowledge and agree that National Associations and the FIH have jurisdiction to impose sanctions as provided in the FIH Anti-Doping Regulations.
- 4. I also acknowledge and agree that any dispute arising out of a decision made pursuant to the FIH Anti-Doping Regulations, after exhaustion of the process expressly provided for in the FIH Anti-Doping Regulations, may be appealed exclusively as provided in Article 13 of the FIH Anti-Doping Regulations to an appellate body for final and binding arbitration, which in the case of International-Level Athletes is the Court of Arbitration for Sport.
- 5. I acknowledge and agree that the decisions of the arbitral appellate body referenced above shall be final and enforceable, and that I will not bring any claim, arbitration, lawsuit or litigation in any other court or tribunal.

SGHA IMAGE RIGHTS POLICY

- 1. I have received and had an opportunity to review the SGHA Image Rights Policy.
- 2. I consent and agree to be filmed, televised, photographed, identified and otherwise recorded during the Event/ Tournament/ League under conditions and for the purposes authorized by SGHA in relation to the promotion of hockey in general.
- 3. I consent and agree to permit SGHA to use images taken of me at the event solely for non-commercial purposes.

SGHA CODE OF CONDUCT, FIH ANTI-DOPING REGULATIONS AND SGHA IMAGE RIGHTS POLICY

Introduction

- Under the Southern Gauteng Hockey Association's Constitution; Bye Laws and League Rules, the SGHA has full jurisdiction and authority with respect to the organisation and conduct of hockey Events/ Tournaments/ Leagues by the SGHA.
- All Participants are subject to the jurisdiction of SGHA.
- All Participants must comply with all rules and regulations of the FIH relating to SGHA events.
- The SGHA Code of Conduct, the FIH Anti-Doping Regulations and the SGHA Image Rights Policy are duly approved regulations of the FIH.
- All Participants must abide by the Code of Conduct, the FIH Anti-Doping Regulations and the SGHA Image Rights Policy.
- SGHA is committed to maintaining the highest standards of behaviour and conduct at all SGHA events.

Who does the SGHA Code of Conduct, the FIH Anti-Doping Regulations and the SGHA Image Rights Policy Apply to?

They apply to all Participants. For this purpose, "Participant" means and includes :

- All team members and officials including players, managers, coaching and support staff (including video operators/analysts), medical and Para-medical staff.
- All SGHA officials including the SGHA Representative, the Tournament Director, Technical Officers, Umpires' Manager, Medical Officer, Media Officer, Judges, Umpires and any other official appointed by SGHA.

Purpose of the SGHA Code of Conduct

- The Code is established to create awareness of and accountability for the promotion of the game of hockey by all Participants.
- All Participants are responsible and accountable for their own behaviour and conduct.
- Clubs bear ultimate responsibility for compliance by the Participants that represent them with the SGHA Code of Conduct, the FIH Anti-Doping Regulations and the SGHA Image Rights Policy.
- Complaints in relation to breaches of any regulations and of the SGHA Code of Conduct, the FIH Anti-Doping Regulations and the SGHA Image Rights Policy shall in the first instance be dealt with by the League Committee during the event and by the Disciplinary Committee after the event is completed.

Purpose of the FIH Anti-Doping Regulations

- The FIH Anti-Doping Regulations are established to promote fair and equitable play.
- It protects a participant's fundamental right to participate in doping-free sport and thus to promote health, fairness and equality among participants.
- All participants are personally and individually responsible for compliance with the Regulations; sanctions for non-compliance may be levied against an individual, their team or their national hockey association.
- The FIH Anti-Doping Regulations are recognised by the World Anti-Doping Agency and is the FIH's contribution to doping-free sport worldwide.

Purpose of the SGHA Image Rights Policy

- SGHA Image Rights Policy is established to allow SGHA to use images taken during SAHA/ SGHA Events/ Tournaments/ League for non-commercial purposes only. The images may be used by the SGHA to promote the sport of hockey and for promotional purposes of a non-commercial nature.



SGHA CODE OF CONDUCT

1. Participants shall at all times conduct themselves fairly and properly on the field of play and any part of the hockey venue/accommodation. Participants may not conduct themselves in a manner or commit any act or omission which may prejudice the interest of hockey or which may bring the game of hockey into disrepute.
2. Without prejudice to the generality of the foregoing, the following shall be regarded as conduct which is improper, unfair, and unacceptable:
 - (a) Verbal/physical abuse or hostility towards any other participant, person or any other member of the public.
 - (b) Disputing, protesting and/or reacting in a provocative or disapproving manner in an inappropriate way toward any decision made by an umpire or official.
 - (c) Feigning injury and/or overreacting to an alleged breach or decision.
 - (d) Charging or advancing towards an umpire or technical official in an aggressive manner when appealing.
 - (e) Using rude or abusive language or hand signals.
 - (f) Abuse of hockey equipment or clothing, venue equipment or fixtures and fittings.
 - (g) Failure to comply with any directives respecting team dress protocols for medal presentation ceremonies
 - (h) Any hostility, verbal or physical abuse towards an accredited Anti-Doping Control Official.
 - (i) Any acts that appear to, or are intended to, influence any participant or which may affect any decision, the outcome of any match or the tournament result. (e.g. an inducement in the form of money or gift).
3. Public Statements
 - (i) SGHA defines a "public statement" as follows:

Any statement in which the whole, part or essence, is made public. Such a statement may be made in a newspaper, magazine, periodical or by any electronic (Internet, E-Mail, etc.) or other means through the medium of television, radio or in any other manner whatsoever, regardless of the circumstances in which the statement was made.
 - (ii) Public statements must be fair, constructive and reasonable and must not involve a personal attack on another player, umpire, appointed official or administrator.
 - (iii) SGHA recognises that fair and reasonable comments on the game in general are essentially in the interests of everyone. However, it further recognises that in the interest of maintaining the generally excellent relations that currently exist between players, umpires and officials, it is necessary to ensure that any such comment and criticism is constructive.
4. Each player and team staff member shall comply with the FIH Anti-Doping Regulations and they shall not direct any verbal or physical abuse or hostility towards Doping Control Test Officials. Any possession of dope-related drugs or drugs on the list of prohibited substances as mentioned in the FIH Anti-Doping Regulations and/or the WADA List of Prohibited Methods and Prohibited Substances, or the commission of any criminal offence relating to drugs, shall be handled in accordance with the FIH Anti-Doping Regulations.

No player, coaching staff, management team or any support staff who is currently serving any active sanction/punishment for a positive drug test shall be permitted to be involved in this event/tournament/league.
5. Betting and Gaming

Participants shall not participate in any form of betting or gaming activities, including online betting or gaming activities, related to the event in which they are participants.



FIH ANTI-DOPING REGULATIONS

The FIH Anti-Doping Regulations is a long and complex document. The following notes summarise key points from the FIH Anti-Doping Regulations but it must be noted that the Acknowledgment and Agreement refers to compliance with the full FIH Anti-Doping Regulations a copy of which is available on the FIH website: www.fih.ch

It is the responsibility of all National/Provincial Associations to ensure that its players, managers, coaches and in particular its medical and Para-medical staff are aware of and have access to the FIH Anti-Doping Regulations.

National/ Provincial Associations must provide its players, managers, coaches, medical and Para-medical staff with a hard copy of the FIH Anti-Doping Regulations on request.

1. The following constitute Anti-Doping Rule Violations:
 - (a) The presence of a prohibited substance or its metabolites or markers in an athlete's bodily specimen. It is each athlete's personal duty to ensure that no prohibited substance enters his or her body. Athletes are responsible for any prohibited substance or its metabolites or markers found to be present in their bodily specimens.
 - (b) Use or attempted use of a prohibited substance or a prohibited method.
 - (c) Refusing, or failing without compelling justification, to submit to sample collection after notification as authorised in these anti-doping regulations or otherwise evading sample collection.
 - (d) Violation of the requirements regarding athlete availability for out-of-competition testing.
 - (e) Tampering, or attempting to tamper, with any part of doping control.
 - (f) Possession of prohibited substances and methods.
 - (g) Trafficking in any prohibited substance or prohibited method.
 - (h) Administration or attempted administration of a prohibited substance or prohibited method to any athlete, or assisting, encouraging, aiding, abetting, covering up or any other type of complicity involving an Anti-Doping Rule Violation or any attempted violation
2. These anti-doping regulations incorporate the prohibited list that is published and revised by WADA (the World Anti-Doping Agency).
3. Athletes with a documented medical condition requiring the use of a prohibited substance or a prohibited method must first obtain a Therapeutic Use Exemption (TUE).
4. Doping controls applies at senior and junior levels for both men and women.
5. For events under the control of the SAHA and/or SGHA, the total number of tests will be determined by SAHA. Matches at which tests will be carried out will be selected randomly by the Doping Control Officer and/or the SAHA Medical Officer in consultation with the Tournament Director. Athletes to be tested will be selected randomly by the Tournament Director or his/her appointee on duty in the presence of the Doping Control Officer and FIH Medical Officer. An athlete may be subjected to a doping control on more than one occasion during an event.
6. The SAHA Board/ SGHA Executive Committee may provisionally suspend an athlete prior to the opportunity for a full hearing based on an Adverse Analytical Finding. When it appears that these anti-doping regulations have been violated in connection with SAHA testing or testing at an event then the case shall be assigned to the SAHA Disciplinary Commission for adjudication.
7. A violation of these anti-doping regulations in connection with an in-competition test automatically leads to disqualification of the individual athlete with all resulting consequences, including forfeiture of all trophies and medals received in that competition.
8. The period of Ineligibility imposed for a violation of relevant articles shall be
 - First violation: two (2) years' ineligibility.
 - Second violation: lifetime ineligibility.
9. If more than two team members are found to have committed an Anti-Doping Rule Violation during the event/ tournament/ league, the team may be subject to disqualification or other disciplinary action.
10. Decisions made under these anti-doping regulations may be appealed as set forth in the FIH Anti-Doping Regulations.



SGHA IMAGE RIGHTS POLICY

1. Definition of Image Rights

For the purpose of this Policy 'image rights' refer to the filming, television, photographs identified and otherwise recorded of Participants during any SGHA event/ tournament/ league.

2. Use of Images by SGHA

SGHA shall be permitted to only use images taken of Participants during its Events/ Tournaments/ Leagues for non-commercial purposes. The images will be used in general to promote the sport of hockey and for promotional purposes SGHA.

SGHA shall be permitted to use and publish the images of Participants taken during SGHA Events:

- SGHA internal publications
- Program books for SGHA events
- Presentations made by SGHA

3. Copyright of Images

The copyright of television images taken by the official host broadcaster and photographic images taken by any officially appointed SGHA photographer remains with SGHA. Written permission must be given for any Participant and/or third party to use these images.

4. Commercial use of Images

In the event that SAHA or any third party would like to use any images taken of Participants during SAHA/ SGHA Events/ Tournaments/ Leagues for commercial purposes, the Participant(s) depicted in the image will be contacted directly or through their Club to ask for their approval. In the event that the Participant(s) refuses approval, the image will not be used.
